Director General Labour Bureau hereby appoints Shri Hariom Dubey to the post of Investigator Grade II (Group B, Non Gazetted, Level 6 of the Pay Matrix), on purely temporary basis in Labour Bureau, Chandigarh, w.e.f. the forenoon of 26.10.2023, consequent upon his nomination by the Staff Selection Commission-NWR vide their letter no. S.11011/8/2019 dated 17.07.2023.

2. Shri Hariom Dubey shall be on probation for a period of two years. The other terms and conditions of appointment shall be same as mentioned in offer of appointment issued by this Office vide letter no. 73/10/2022-Admn.I dated 26.09.2023.

3. The basic pay of Shri Hariom Dubey is hereby fixed at Rs. 35400/-, Cell-1 of Level-6 of Pay Matrix, under F.R. 22(1)(b) w.e.f. the date of his appointment in the grade.

4. The appointment of Shri Hariom Dubey to the post of Investigator Grade II in this Office, is further subject to a condition, as mentioned in letter No. E-OP/Running/NOC/Goods Guard/2023 dated 23.10.2023 issued by the Office of the DRM, Personnel Department, North Central Railway, Prayagraj, Uttar Pradesh, that Shri Dubey will refund an amount of Rs. 129921/- (One Lakh Twenty Nine Thousand Nine Hundred twenty one only) on demand by the Government of India, if Shri Dubey resigns from the post of Investigator Grade II on or before 26.04.2028. Shri Dubey is directed to furnish a bond of Rs. 129921/- (One Lakh Twenty Nine Thousand Nine Hundred twenty one only), stipulating the above condition, within a period of seven days from the date of issue of this Order.
