OFFICE ORDER NO. 39 OF 2022


in exercise of the powers conferred under rule 14 of the Delegation of Financial Power Rules, 1978 read with Rule 142 of Central Treasury Rule, Sh. B.B.S. Negi, Joint Director, Labour Bureau, Shimla is hereby declared as "Head of Office" in respect of Labour Bureau, Shimla for all purposes with immediate effect or until further orders.

2. In exercise of the powers conferred by item 54 of Appendix (I) Rule 2 (6) of F.Rs and S.Rs the undersigned also declare Sh. B.B.S. Negi, Joint Director, Labour Bureau, Shimla as "Controlling Officer" for the purpose of Travelling Allowance and Medical Reimbursement of the officers below the level of Assistant Director. However, Shri S.S. Negi, DDG will be the Controlling Officer in respect of officers of the level of Assistant Director and upto the level of Director for the purpose of Travelling Allowance adjustment. The Medical Reimbursement claims of the officers of the level of AD and above and TA adjustment bills of DDG will be submitted to the Director General.

3. The undersigned also hereby delegates to Sh. B.B.S. Negi, Joint Director the following powers subject to the conditions specified in relation to corresponding items of the supplementary and General financial power Rules.

- i) To decide the shortest of two or more routes except in the case of Dy. Director General, Directors/ Jt. Directors, Dy. Directors, Administrative Officer and Assistant Director in whose case the power will continue to be exercised by the Head of Department.
- ii) To sanction advances to the Govt. servants in connection with natural calamities.

4. In exercise of the powers conferred by Rule 13(3) of the Delegation of Financial Power Rules, 1978 as amended from time to time, the undersigned as Head of Department hereby also authorizes Sh. B.B.S. Negi, Joint Director, Labour Bureau, Shimla to exercise powers to incur recurring and non-recurring contingent expenditure to the extent indicated in the Annexure to this order.


