
OFFICE ORDER NO. 40 OF 2022

The pay of Shri Sanjeev Kumar, Staff Car Driver Grade II, who has been granted 2nd financial up-gradation in Level 5 of the Pay Matrix w.e.f. 26.11.2021 under the Modified Assured Career Progression Scheme (MACP) vide this Office's Order No. 30 of 2022 dated 28.02.2022 issued under file of even number, on his opting to have his pay fixed from the date of his next increment in the lower grade, is fixed in accordance with the FR 22(1)(a)(1), in his substantive grade, as hereunder:-

2. The fixation of pay and payment of arrears arising thereof, if any, is subject to adjustment in the light of audit objections/errors that may come to notice later on.

3. There shall be no further fixation of pay at the time of his regular promotion if it is in the same grade pay as granted under MACPS/restructuring/up-gradation. However, at the time of actual promotion, if it happens to be the post carrying higher grade pay than what is available under up-gradation, no pay fixation would be available and only difference of grade pay would be available.
